Scope and Eligibility

Financial Support and Funding Mechanism

The institution will provide financial assistance to faculty members for attending or presenting

papers in conferences, workshops, or seminars outside the institution. The funding will be

allocated as follows:

• Attending programs within the district: ₹500

• Attending programs outside the district but within the state: ₹750

Attending programs outside the state: ₹1000

The 'Anuvida' fund will be generated through voluntary donations from willing faculty members,

promoting a sense of ownership and community involvement.

Fund Release Criteria and Application Process

The 'Anuvida' fund will be released annually at the end of each academic year. Faculty members must submit a funding request, accompanied by documentary proof of participation or a paper presentation. The Internal Quality Assurance Cell (IQAC) reserves the right to accept or reject applications at its discretion, ensuring that the funding is utilized effectively and efficiently.

Responsibilities and Roles

The IQAC will oversee the implementation of this policy, review applications, and manage the fund. Faculty members are responsible for submitting funding requests, providing documentary proof, and utilizing the fund for knowledge advancement activities.
